Joining Fee

A joining fee applies to all new members on direct debit.

The joining fee entitles the member to renew or restart their membership within a twelve month period following the expiration of their membership. Cost of the Joining fee is \$30

Term Memberships

Term memberships are a 3, 6 or 12 month memberships that have a start and end date.

Direct Debit Memberships

Direct Debit is an automatic monthly deduction from a debit or credit card (Visa, Bankcard or MasterCard only)

The minimum term of a Direct Debit Membership is 3 months. After the initial three (3) months, the member may cancel the direct debit.

To cancel a direct debit membership, the member must complete a direct debit cancellation request form and lodge it to Revolution Spin Fit Staff by the 25th of the month. Cancellations received after this date cannot be processed until the following month.

Deductions will be drawn out around the 4th day of each month

Suspensions

A member may suspend their membership. A membership can be suspended for a minimum term of one week and maximum term of 12 weeks. A member must specify a start and finish date. Early reactivation is permissible.

To suspend a membership, the member must complete a suspension form and lodge it to Revolution Spin Fit prior to the commencement of their suspension. Cost while the Suspension is \$5 a week
